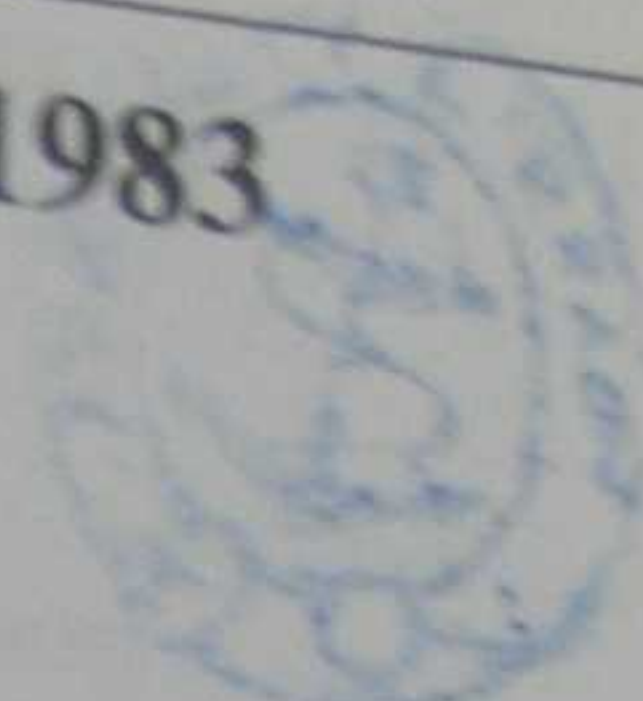

Introduction

1. Issuing prices of items in the officers' clothing range have been reviewed in the light of current costs. Revised prices to be brought into force from 1 April 1983 are shown in the ANNEXES to this DCI.

- ANNEX A : Issuing prices of Naval Officers' clothing
- ANNEX B : Issuing prices of RM Officers' clothing
- ANNEX C : Issuing prices of QARNNS Officers' clothing
- ANNEX D : Issuing prices of WRNS Officers' clothing

Notes

1. The letter O after description indicates that the item is obsolescent and available from Service sources only while stocks remain.
 2. The symbol < denotes an increase in price.
 3. The symbol > denotes a decrease in price.
 4. Revised prices for made-to-measure items are not yet available pending receipt of new contracts commencing 1 April 1983. These prices will be promulgated separately.
 5. An increase in stores overhead rates from 34 to 38 per cent has affected the issuing prices of all items in the officers' clothing range.
2. VAT is to be charged on the sale of all cash clothing except:
 - a. In Fleet establishments abroad.
 - b. In HM ships outside territorial waters for more than 15 days or where a voyage of less than 15 days includes a call at a foreign port.
 - c. Where items are being purchased under the Personal Export scheme (see BR96, Article 0968).
 3. Revised rates of officers' Uniform Upkeep Allowances effective from 1 April 1983 will be promulgated separately.
 4. To assist Supply Officers in highlighting the more substantial price increases the few items showing rises greater than £1.00 at VAT exclusive rates (mainly officers' caps and shoes), have been underlined in ANNEXES A to D.
- Ratings and RM Warrant Officers, NCOs and men**
5. Issuing prices of clothing for ratings and RM Warrant Officers, non-commissioned officers and men, Kit Upkeep Allowances (KUA) and clothing gratuities remain as published in DCI RN 316/82 and later DCIs for new items and are to continue in force until 31 July 1983.
