BERET BADGES FOR RN AND RNR CHAPLAINS (U)

1. Embroidered beret badges for RN and RNR Chaplains will, in future, be obtainable from Service sources.
2. From the date of this DCI, beret badges are to be issued in uniform outfits of entitled officers. Cash grants, in which, until now, provision for a beret badge has been made, are being reduced accordingly. Details of the changes in outfits and grants are given in the ANNEX to this DCI.
